### 1. Project Description

The Bango Wind Farm is located in the Hilltops and Yass Valley Local Government Areas, approximately 8km south west of Rye Park and 20km north of Yass. The nearest township is Boorowa, which is located approximately 12 km to the north along Lachlan Valley Way. The site is characterised by a mix of native woodland and open-forest, native pasture, exotic pasture and cleared land.

The project was granted State Significant Development Approval (SSD6686) by the Independent Planning Commission on 1 May 2018.

On 25 May 2018, a third-party appeal was made to the Court by several landowners challenging the granting of the IPC consent. On 6 December 2018, an agreement was reached during a conciliation conference ordered pursuant to s 34 of the *Land and Environment Court Act 1979* (LEC Act).

A Modification (SSD 6686 MOD 1) was granted on 7 June 2019 to approve the subdivision of land (to create one freehold lot for the construction of the collector substation) and amend the description of the Land to include two additional parcels of land to accommodate the oversail of three wind turbine blades onto these two lots.

The Minister for Environment and Energy granted approval on 9 August 2018 with conditions covered by EPBC 2013/6810. A variation to the Approval was granted on 4 April 2019. The Approval holder is Bango Wind Farm Pty Ltd (ABN 38 143 401 067).

The project involves construction, operation and decommissioning of the wind farm. Construction on the site commenced on 14 August 2019 (commencement of the action).

The reporting period is from 14<sup>th</sup> August 2019 to 13<sup>th</sup> August 2020.

## 2. Description of activities

Activities undertaken during the reporting period (14<sup>th</sup> August 2019 – 13<sup>th</sup> August 2020) are summarised below:

- Upgrade of the entrance to the wind farm site at the intersection of Lachlan Valley Way
- Installation of permanent and temporary meteorological monitoring masts
- Clearing and grubbing
- Commence construction of site access tracks and associated drainage works
- Establish construction compound area including fencing, environmental controls, site offices, amenities, and parking area
- Construction of concrete batch plant #1 Kangiara (western) cluster
- Commence construction of batch plant #2 Mt Buffalo (eastern) cluster
- Construction of a 132kV substation and switchyards with associated structures and buildings
- Commence turbine site preparation for wind turbine sites
- Blasting of non-rippable rock at some turbine locations
- Formation of concrete foundations for wind turbines Kangiara (western) cluster
- Commence installation of 33kV overhead transmission lines and communication cables between the wind turbine clusters and the main collector substation
- Commence installation of 33kV underground cables and communication cables within the Kangiara (western) wind turbine cluster.
