Project update

South West Renewable Energy Zone Access Rights Tender

Since April 2024, Squadron Energy has been participating in the highly competitive South West Renewable Energy Zone (REZ) access rights tender process. The tender was run by AEMO Services to determine which projects will receive rights to connect to the new transmission infrastructure:

- Project EnergyConnect (PEC), and
- Victoria to New South Wales Interconnector West (VNI West).

The result of the tender process was [announced on 23 April](#). Unfortunately, Conargo Wind Farm was not selected for a connection access right.

The indicative capacity available for the South West REZ was 3.98GW. AEMO Services highlighted the strong interest in the tender, receiving bids representing more than 15GW of generation and storage infrastructure.

Next steps

Squadron Energy is continuing to develop Conargo Wind Farm and is exploring other options and connection pathways.

There is potential to connect to the existing 132kV transmission infrastructure near the project or consider alternative connection pathways. EnergyCo may in the future determine whether there is remaining capacity in the planned South West REZ transmission infrastructure. Access rights to any additional capacity may be subject to a further tender process.

We will keep the community and our stakeholders updated as we continue to work with Transgrid and EnergyCo regarding grid connection options for Conargo Wind Farm.

Biodiversity studies are ongoing, and detailed visual impact assessment will commence soon. Over the coming months, we will continue to refine the project design based on insights gained from ongoing environmental assessments, feedback from community engagement and our potential grid connection options.

The project team will visit the area soon to meet with stakeholders. We encourage you to share your questions, concerns and feedback with the team. Please contact us if you would like to arrange a meeting using the contact details below.
