1 Position Summary

Reporting to the Director – Corporate Development / Director Capital Markets (as assigned), the Senior Investment Analyst is responsible for providing financial modelling and analysis for the portfolio of existing and future renewable energy projects.

1.1 Key Responsibilities

- Manage the process for tracking and documenting model assumptions and benchmarking database.
- Source and process data required for financial analysis on activities of the company or specific topics as required. Prepare presentations to communicate conclusions and recommendations to senior management, as well as third parties (e.g. external financiers, consultants).
- Support the team in undertaking Mergers and Acquisitions (M&A) transactions (buy or sell side) and financial close processes, including preparation of Information Memorandums, Requests for Proposal (RFP) responses or commercial proposals.
- Support Finance team with budgeting process and assist preparation of and/or checking of financial covenant calculations for reporting to lenders.
- Manage and lead the work of a team; provide motivation, encouragement, and opportunities for development; manage any underperformance issues if required in consultation with People and Culture; actively monitor leave requests of team.
