1 Position Summary

Reporting to the Executive General Manager People and Culture, the Sustainability Manager plays a pivotal role in fostering responsible business practices and enhancing Squadron Energy's (SQE's) reputation as a socially and environmentally responsible company.

The position will be responsible for coordinating the development, delivery, and communication of SQE's Environmental, Social and Governance (ESG) strategy and working closely with key internal and external stakeholders to ensure the development and implementation of required ESG policies, procedures and reporting frameworks.

Key Responsibilities

Sustainability strategy lead (development and implementation)

- Coordinating the development, implementation, and monitoring of SQE's Sustainability strategy in partnership with key stakeholders.
- Proactively identifying sustainability issues for SQE, understanding their implications, and supporting relevant leaders in addressing them.
- Collaborate with cross-functional teams to integrate sustainable practices into all aspects of our operations.
- Leading the development, implementation, and maintenance of Sustainability policies, systems and processes to support Sustainability reporting activities, including preparing quarterly SQE Board and Committee updates on progress.
- Leading ESG initiatives across the business, working with Subject Matter Experts and working groups to help amplify/support successful roll out and implementation of projects aimed at delivering the Sustainability strategy.

Reporting and compliance coordination

- Plan and oversee sustainability reporting, including the preparation of reports for stakeholders and regulatory bodies.
- Perform ongoing data quality assessments, identifying discrepancies and inconsistencies, and resolving them, and driving the ongoing enhancement of Sustainability related data and performance reporting.

- Working closely with leaders, data owners, technical functions, and external assurance providers to establish standardised reporting processes.
- Monitoring and maintaining a disclosure calendar of current and pending voluntary, stakeholder, and regulatory ESG disclosures to stay current on regulatory changes and industry standards.

Communication and education

- Educate and train employees on sustainable practices, fostering a culture of environmental responsibility.
- Build relationships with external partners, suppliers, and community organisations to advance sustainability goals.
- Participate in industry conferences, seminars, and networking events to stay informed about emerging trends and best practices.
- Develop a sustainability communications plan to keep stakeholders informed of progress.
